CALL TO ORDER: GR called the meeting to order at 4:20 pm.

MINUTES: GR moved that the January minutes be approved as corrected. PF seconded and the Board unanimously approved.

ANNUAL HOMEOWNERS MEETING: GR presented preliminary drafts of information to be distributed for the Annual Meeting. He will finalize to include suggestions from the Board.

DRC: *GR* moved that the Board move into Executive Session to discuss a legal matter including advice of Counsel. *BM* seconded and the Board unanimously approved. All non Board Members left the room. *GR* moved that the Board move out of Executive Session. *BM* seconded and the Board unanimously approved. Non Board Members returned.

FINANCIALS: The 2013 Financial Statements are still incomplete. JH and GR will meet with Peggy Long, the ENPHA Accountant, to complete.

CORPORATE DOCUMENTS: GR will confirm with the Town of Silverthorne (TOS) that the proposed PUD amendment is legal. Members are not responding to the issue by ballot as hoped. If it is deemed legal, we will pursue the confirmation via email or the least expensive alternative. Two thirds positive vote of homeowners is needed to pass the proposal.

SUB ASSOCIATIONS: A decision on the distribution of funds to sub associations has been deferred pending more discussions with applicants.

FACILITIES AND MAINTENANCE: JT, Monthly budget is attached. Arrangements will be made to have the Community Center professionally cleaned monthly. Decisions will be made next month.

DEVELOPMENTS, SILVER TROUT: JT reported that the Subdivision Approval expired 12-23-2013 as financing had not been obtained. The site plan expires April 23 and is eligible for for a 90 day extension, until July 23. After this date, if it is not been approved, it will have to start over. They did spray for noxious weeds last year and must continue to do so in all areas.

COMPLIANCE: JA, report attached.

MANAGER: SR, The Annual Snowshoe Party will be held Saturday at 5:30 at the Community Center. There is still a bird problem in the Pavillion.

ADJOURNMENT: GR adjourned the meeting at 6:15.
